

#### PRIVACY POLICY

This privacy policy ("Privacy Policy") sets out how OOMPH! Health Coaching ABN: 65577460150 ("we") uphold your rights under the Australian Privacy Principles contained in the Privacy Act 1988 (Cth) ("Privacy Act"). This Privacy Policy for OOMPH! Health Coaching lets you know what personal information of yours we hold, what we do with it, who we may disclose it to and how you can assess the personal information we hold about you. You can also find out here how to change inaccurate personal information and how to opt out of receiving communications from OOMPH! Health Coaching.

OOMPH! Health Coaching may change this Privacy Policy from time to time by updating this page. This Privacy Policy is effective from 15 October 2018.

#### What we collect

OOMPH! Health Coaching may collect the following information:

- Name
- Contact information including email address and mobile
- Date of birth
- Emergency contact person
- · Bank account and/or credit card details
- Payment history
- Demographic information such as postcode, preferences and interests
- Other information relevant to customer surveys and/or offers
- Sensitive information\*
- For employment or other recruitment purposes, the above as well as employment and education details and generally, information relating to qualifications and experience

An individual is not obliged to provide their personal information to OOMPH! Health Coaching however, without certain information from an individual it may not be possible for OOMPH! Health Coaching to provide its products and/or services to the individual.

## How OOMPH! Health Coaching collects and holds your personal information

Where possible, we will generally collect your personal information directly from you. We may also collect personal information from as well as from a centralised online booking system, when you purchase or book OOMPH! Health Coaching services via that channel.

We may also collect personal information from you via our website <a href="https://www.oomphhealthcoaching.com.au">www.oomphhealthcoaching.com.au</a> promotional activities, competitions and events.

## \* Sensitive Information

For the purposes of this Privacy Policy, sensitive information means the information a member has disclosed to OOMPH! Health Coaching about their physical and mental health and well-being.

Sensitive information will only ever be used for providing services to you. Such information will not be used or disclosed for any other purposes without consent, except in exceptional cases when disclosure may be required by law or is necessary to protect the rights or property of OOMPH! Health Coaching, or any member of the public, or to lessen a serious threat to a person's health or safety. For the purposes of this Privacy Policy sensitive information is a subset of personal information.

The types of sensitive information generally collected by OOMPH! Health Coaching include information relating to:

- Your health
- Your weight and body measurement
- Your medical history
- Whether you smoke or are pregnant
- Whether you are on any medication
- Other health related information that is necessary to properly advise you about fitness training.



### What we do with the information we gather

We will only use and disclose your personal information so we can provide you with the services you have requested as well as for the following directly related secondary purposes:

- Managing your account with OOMPH! Health Coaching
- To improve our products and services
- Send promotional emails and sms (short message services) to you about new products, special offers or other information which we think you may find interesting using the email address or mobile number that you have provided
- Contact you for market research purposes. We may contact you by email, phone, sms, fax or mail
- To customise the OOMPH! Health Coaching website according to your interests
- We may provide your information to our third party partners for marketing or promotional purposes provided we first have your consent

We will never sell your information.

## Who will OOMPH! Health Coaching disclose your information to?

We may disclose your personal information to third parties including third parties who may offer OOMPH! Health Coaching's services or products that you may partake in at the third party partner for the purpose for which the third party partner collects it. That is, generally, OOMPH! Health Coaching will only disclose your personal information to third parties for the purpose of providing OOMPH! Health Coaching services, classes and products to you or other directly related secondary purposes as set out above. OOMPH! Health Coaching may otherwise disclose your personal information with your consent or if it is required or authorised by law.

OOMPH! Health Coaching may disclose your personal information to third party services providers overseas. However, where your personal information is disclosed to an overseas recipient, we will also take adequate measures to ensure that your personal information is handled securely.

OOMPH! Health Coaching's website is hosted on the Wix.com platform. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. Wix.com store your data on secure servers behind a firewall.

By providing OOMPH! Health Coaching with your personal information, you consent to this disclosure of your personal information.

# Marketing

Where we have obtained your consent to do so, or in circumstances where you would reasonably expect that your personal information would be used or disclosed for this purpose, we may contact you from time to time with marketing material about our other products or services or third parties. At any time you may opt out of receiving this marketing material by contacting OOMPH! Health Coaching by emailing (info@oomphhealthcoaching.com.au .). Your consent to receiving this information will remain current until you notify OOMPH! Health Coaching otherwise.

### Security

We are committed to ensuring that your information is secure. In order to prevent loss, misuse, and unauthorised access, use, modification, disclosure, alteration, or destruction we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

However, you should keep in mind that the transmission of information over the Internet is not completely secure or error-free. In particular, e-mail, social media, and messaging apps may not be secure, and you should therefore take special care in deciding what information you send to OOMPH! Health Coaching via these channels.

# How we use cookies

A cookie is a small file that asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web



application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We may use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve the OOMPH! Health Coaching website in order to tailor it to customer needs. We only use this information for statistical analysis purposes.

Overall, cookies help OOMPH! Health Coaching provide you with a better OOMPH! Health Coaching website, by enabling OOMPH! Health Coaching to monitor which pages you find useful and which you do not. A cookie in no way gives OOMPH! Health Coaching access to your computer or any information about you, other than the data you choose to share with OOMPH! Health Coaching.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the OOMPH! Health Coaching website.

#### Links to other websites

### **Right of Access and Storage**

Where we hold information that you are entitled to access, we will endeavour to provide you with suitable range of choices as to how access is provided (e.g. email or mailing it to you). A fee may be charged to cover the cost of retrieval.

If at any time you believe that personal information we hold about you is incorrect, incomplete or inaccurate, then you may request that we change it.

OOMPH! Health Coaching will destroy or de-identify your personal information as soon as practicable once it is no longer needed for the purpose for which it was collected. However, we may be required by law to retain your personal information after your relationship with OOMPH! Health Coaching has expired. In this case your personal information will continue to be protected in accordance with this Privacy Policy. If we destroy personal information we will do so by taking reasonable steps and using up-to-date techniques and processes.
